#### **Professional Standards 2018 Training Requirements**

At the MML Gathering in October, Margery Jackman, Professional Standards Officer, presented an outline of the Professional Standards training requirements for 2018. The key focus was on Maintaining Safe and Respectful Relationships.

The 2018 Professional Standards training comprises of three components:

- 1) MML Forum Presentation (13/10/2017) by Margery Jackman
- 2) Personal Reflection on your own ministry using the Reflection & discussion sheet
- 3) Collegial discussion of key issues arising from step 2. You may like to organise local meetings to complete step 3.

For those who attended the Gathering please note you have completed the *first part* of the training requirements and are required to complete the steps 2 and 3.

Please note the 2018 Professional Standards training is required to be completed by all MML ministries by 30 June 2018.



# **Royal Commission Recommendations**

You will be aware the <u>recommendations from the Royal Commission</u> were released in December 2017. There are a number of areas that MML will need to consider including the requirement of professional supervision, performance appraisal, and training in regard to Codes of Conduct, Child Protection standards and best practice.

Some of these practices MML has in place, and some areas will require further development. The Institute is working closely with CRA and other bodies to address these and MML will explore what changes in practice will be required.
