A Guide for Boards, Board sub-committees, Leadership teams and staff in designated leadership roles, to accompany the recording of the seminar "Exploring principles of good governance in the context of mission: Case Study on subsidiarity" held on June 25, 2021.

This Resource Guide is provided to assist Boards, Board subcommittees, Leadership teams, senior staff and those with designated leadership roles, to review their roles and responsibilities and decision-making processes in light of the principle of subsidiarity, a core element of Catholic Social Teaching. The resources can be used by small groups (e.g. as part of a Board meeting or ministry leadership group gathering) or as a self-paced governance formation opportunity for people currently in governance, leadership, quality assurance or ministry formation roles.

The recording of the June 25 seminar can be considered in three (3) parts. The contents of Parts 1 and 2 are summarized in the ppts provided:

- ➤ Part 1: An overview of good canonical and civil governance procedures, including an explanation of the meaning of 'subsidiarity' and 'synodality'. The presenter, Adj Prof Susan Pascoe, refers to key points in the context of a recent review of the Diocese of Parramatta in which she was involved. This is Case Study 1. (Susan Pascoe approx. 50 mins)
- ➤ Part 2: Sally Bradley rsm, Executive Director of *Mercy Works*, a Community development ministry, presents Case Study 2, outlining a recent example relating to an Emergency Relief Appeal conducted by *Mercy Works* for people in the Simbu region of Papua New Guinea during COVID. (Sally Bradley rsm approx. 30 mins)
- ➤ Part 3: A brief consideration of the strength of the decision-making models outlined, given the challenges of decision-making in the context of COVID 19 (Susan Pascoe and Felix Pintado, Mercy Health approx. 20 mins)

 - 4. The anticipated and the actual outcome of the Appeal
 - 5. Implications for the Board and the Executive Director re any future initiatives
