Message from the Executive Officer

The ongoing effect of the Covid pandemic continued to challenge ministries during this year. The restrictions resulting from the pandemic had a particularly strong impact on our ministry centres, requiring extreme flexibility and creativity as rules, compliance and restrictions changed, often with minimal notice. The floods in Northern NSW continue to impact our ministries in Northern NSW and the capacity for ongoing connection with clients, predominantly music students. McAuley Ministries continued to offer support by hosting regular Managers' meetings, via Zoom, to share experiences and ideas from those 'on the ground'.

A Professional Development opportunity in March 2023 to explore Integral Ecology, was a success, with sisters requesting opportunities to delve deeper as time allows. Feedback was sought on other areas of need and interest, for professional development, and will form the basis for future offerings.

While these professional development

opportunities were hosted by MML, sisters in active ministry throughout the Institute were invited and did attend.

As ministries centres have been reviewed an implementation plan and budget are developed and approved by the Board. The Implementation plans have provided a great sense of purpose and direction for those Ministry Centres who have begun working with them. All the implementation plans reflect the deeper purpose of our centres, many encompassing the spirit of Laudato Si and attuned to the cry of the earth and the cry of the poor. Mercy Hub, Santa Casa and Seville have made remarkable progress, with both Santa Casa and Seville sharing a reflection on their experiences below.

Sisters, managers, and staff within MML continue to respond anew to the changing world around us. The ministry of each one has contributed to the influence of Mercy in our world and on others. Changes in staff, environmental and human suffering in local and global settings have set a context of challenge and opportunity for those involved in MML. The consistent and strategic efforts of this year are foundational for the future.

Our Story

Our Mission

The Board of McAuley Ministries ² exercises governance for the formal non incorporated ministries of ISMAPNG.

The Board seeks to govern, empower and enable those ministries in the provision of excellent, professional services.

Our Vision[®]

The people and ministries in McAuley Ministries give expression to God's mission of mercy. The ministries enhance the quality of life of those who are served.

Sisters and lay people within MML serve with a strong sense of purpose, confident that they contribute to the larger reality of mercy mission.

Under the McAuley Ministries banner, Sisters and partners in Mercy provide a wide range of services that are truly spiritual and corporal works of mercy in today's world.

They are:

- Ministering as educators, theologians, scripture scholars, liturgists, writers and publishers, poets, researchers, musicians, artists, bioethicists, environmentalists and ecologists, lawyers and advocates for justice
- Providing counselling, psychological therapy, pastoral supervision, mediation, retreats and spiritual direction
- Working in community development, and facilitation
- Supporting rural communities
- Offering hospitality in retreat, spirituality and heritage centres
- Teaching music, speech and drama.

A mission statement explains the overall purpose of the organisation – what you do, for whom you do it and the benefit – a vision statement gives the picture of the preferred future.
MML uses the term formal non incorporated ministries to distinguish the ministries in MML that offer a professional service as separate from the many non incorporated ministries of ISMAPNG.
A vision statement answers the question, "If the organisation fulfills its mission, what will the future look like?" In other words, the vision is a statement that describes how the future will look if the organisation meets its mission.

The MML Board has met seven times in the 2021 – 2022 year.

All compliance requirements with ASIC and ACNC have been met.

Risk and safeguarding policies are firmly in place.

The Audit Report is complete and available with this report.

The financial viability of the Company is guaranteed by the Institute.

The Directors consider carefully and in detail the comprehensive reports presented by the Finance Officer at each meeting. The Board provides an annual budget to fund each of its ministries and its operations.

The Members re-appointed ShineWing Auditors for the 2021-2022 financial year.

Objectives 2022-2024

1. Ministries within MML are living expressions of the mission of ISMAPNG (the Institute) to embody God's mission of Mercy in today's changing world

2. The Board promotes the growth of MML by proactive collaboration with Mission Integration in nurturing new ministries

3. The organisation retains its flexibility in responding to the developing needs and demands of the Institute and the world

4. All ministries within MML offer professional, quality services

5. Each site-based ministry within MML is well managed, accountable to MML and moves through its life cycle in a way that is appropriate to the ministry and to the people it serves

6. Processes of communication are constantly reviewed to facilitate and ensure effective coordination and interaction between the Institute and MML.

MML Ministries

At the end of June 2022, MML engaged 37 sisters, including the Executive Officer Gaye Lennon RSM and employed 32 staff in a total of 38 ministries. Of the sisters, 37 are engaged in full or part-time individual ministry, one manages a centre which employs professional staff (music teachers) and three manage centres where support staff are employed.

Of the employees, one manages a centre and the remaining 31 employees include music teachers, support staff working in administration, program development, guest services or as cleaners, gardeners/maintenance staff or cooks. The employment status of these employees is as follows: full time staff 4, part time staff 4 and casual staff 24.

There are, as well, many volunteers who provide invaluable support at St Catherine's House of Hospitality, Tuart Hill. 00


Four ministry centres and one music academy are supported by MML. These are St Catherine's House of Hospitality (Tuart Hill), Santa Casa (Queenscliff), Star of the Sea Retreat Centre (Apollo Bay), Seville Mercy Conference Centre (Cairns) and Maclean Music Academy (Maclean).

The majority of individual sisters in MML provide services on a part-time basis and some have additional commitments to a variety of other ministries. Most work from Institute owned premises while a few work out of parish or other premises.

On 30 June 2022, the MML Administration Office located at Stanmore is staffed by Sr Gaye Lennon RSM her part-time Executive Assistant, Mrs Jenny Hildebrandt and the part-time Finance Officer, Ms Christine Shen.

Santa Casa Retreat Centre



How has developing and the ongoing review of an implementation plan impacted the direction of your Ministry?

The Implementation Plan has been a great tool for the on-going planning at Santa Casa especially with the use of the 'Traffic Light system'. As we review activities in our plan we highlight them as follows: Green = working well, Yellow = still needs work, Red = not started or not working, Blue = new additions to plan. This gives a real indication of what is working, what is not working yet, but still viable for the future, and what has no possibility at all.

The productiveness of the implementation plan is evidenced by the appointment of Cathy Solano rsm as the programme coordinator and the work that she has so far achieved; the appointment of an Advisory team, including Jenny Kirby olsh, Rod Cole Clarke, Kath Tierney and Anna Negro; and the continuation of the reference group including Cathy Solano rsm, Joan Wilson rsm and Margie Abbott rsm. The number of groups coming to Santa Casa has increased and with a wider diversity. Taizé Prayer is being offered several times a year; new day programs are available to the people of the Bellarine and Geelong and next year we are engaging some new facilitators for retreats at Santa Casa.

What was the purpose and direction for your ministry centre during this year?

Always keeping in mind, the needs of the time, we offer Santa Casa as a welcoming and sacred place where those that come can find nourishment and refreshment for body mind and spirit whether it be for groups or for individual people seeking a contemplative environment for the deepening of spirit. To this effect, Santa Casa is a place offering transformative experiences and educative programs which are not made available in our institutional churches today.

Santa Casa Retreat Centre



Reflecting on Pope Francis's challenge for a true ecological approach, what were the successes and challenges you experienced?

Those working at Santa Casa have become more conscious of our impact on the environment. We source environmentally sustainable products as much as we can and food wastage is minimal. Composting is used both in our garden and council waste.

There are large water tanks for garden use and we have been able to maintain the Australian native garden which attracts the bird, bee and animal life that is indigenous to the area.

We have been able to highlight the preciousness of, and the vulnerability of our oceans, with flyers provided through 'The Mercy engaging with U.N. Ocean Conference displayed, and copies available for people take and use.

We provide a stillness Retreat where retreatants have the opportunity to relax and contemplate the beauty of Nature and God's presence in the Ocean calling them to new life. Additionally, school



groups have used Santa Casa as a base for their Environmental Days.

The monetary and environmental costs of running a large centre are always a challenge. There was a problem with the hot water system which, until addressed, resulted in much water wastage and Covid-19 necessitated the use of chemical cleaners and hand sanitisers.

Our biggest disappointment is that we have not yet been able to install solar panels. This would have a huge impact both on our environment and our budget and be aligned with the Environmental policy of our local borough.

How has developing and the ongoing review of an implementation plan impacted the direction of your Ministry?

If you fail to plan you plan to fail; setting up our implementation plan has aided the growth of the ministry to exceed my expectations. Once we formulated a clear plan for the ministry at Seville, we went about implementing the delivery of the plan. With the plan for the ministry documented we were able to clearly see the resources and staff need to deliver it, and more importantly we can track our progress against it. I am currently preparing a detailed plan for the management of the gardens and lawns at Seville, so we can apply the same principal. A plan of action for the rainforest at Seville is also being formulated by a small working group comprising MML employees, Institute staff and Sisters and a loyal volunteer who was a major part of the original project and planting of the rainforest 15 years ago.

What was the purpose and direction for your ministry centre during this year?

The purpose of Seville is to be a Mercy home for Laudato Si. The staff here have adopted Laudato Si into ALL aspects of the ministry. Staff developed a program aimed specifically at the next generation.

Reflecting on Pope Francis's challenge for a true ecological approach, what were the successes and challenges you experienced?

We continually look for new and innovative products that meet our purchasing processes and do not compromise our high standards. I am amazed at the growth in myself and in the staff with our knowledge of Laudato Si and how to apply these principals in our everyday lives and in our ministry. We haven't always gotten things right first go as some goods we trial simply do not function and meet our high standards, but further research often leads us to amazing new products that are both useful to the ministry and sustainable.

Seville Mercy Conference Centre

What opportunities can you see emerging for your ministry centre?

I see great potential for the growth of our ministry. Our eco experience with Catholic schools has generated a lot of discussion, and more and more schools are considering our offering. The first school to utilise this program was St Vincent's College from Potts Point in Sydney; they have already booked a return trip in 2023 and have been telling other schools in their area about what we have to offer students and staff. Locally, we have developed an Earthkeepers Program targeted at Grade 2 students. Several local schools have already utilised this program and the ministry team are now developing this further to suit the upper primary levels as requested by the schools. This is exciting as we can give kids a greater understanding of their place in the environment and their role in the care for this planet - training up the next generation to have greater respect for this planet.
